4. The studio takes utmost care with respect to the exposure, editing, duplication and delivery of video products and services offered. However, in the event the studio fails comply with the terms of this contract due to any event or act in control of the studio, the studio's liability is limited to refund of the retainer.
5. No videotape, either in progress or completed, may be taken off the studio premises unless balance due for same is paid in full.
6. Client assumes copyright responsibility for all music used in video unless paid additional fee for royalty music.
7. NOTICE OF COPYRIGHT: It is ILLEGAL to copy or reproduce these videotapes elsewhere without videographer's permission, and violators of the Federal Law will be subject to its civil and criminal penalties.
8. The studio is not held to a specific date for completion, however, we strive to complete within 6 to 8 weeks from event date.
9. When contracting Studio for any packages requiring filming of the reception, it is necessary to provide meals to the videographers during the reception. It is customary that the videographers be served directly following the bridal party as not to miss any important events. If these meals are not served an additional \$20 per videographer will be charged and balance required before final video is completed.
